Description of the Project/content of contract, context, timeline, and additional information

The Government of the Republic of Ecuador, through the Ministry of Energy and Mines, with the financial contribution of KfW of Germany, has a donation of 4,4 million Euros in order to perform the update of the Isabela's Hybrid Power Plant – Phase I, which currently has a capacity of 1,62MW biofuel, 0,95MWp of photovoltaic, and an energy storage system of 330 KWh.

With this update the purpose is to increment the capacity of the photovoltaic plant in 1MWp and the energy storage system between 2,2 to 4,4 MWh; and this new infrastructure must be connected in a near future with the automatic control system of the current power plant.

The contribution is directed to contract a company, which under the turn-key modality performs de engineering, provision, construction and commissioning (EPC mode), of the update infrastructure of the power plant, and later to contract the interconnection of that update with the current Power Plant. Similarly, we consider that the contribution, via the present tender process, will serve to contract a Consultancy Company in charge of the elaboration of the technical specifications and tender documents for the 2 tender processes of update and interconnection, of the supervision of the works, and the supervision and monitoring of the periods of responsibility for defects both of the update and the interconnection contracts.

The Solicitor can be a private entity, an Association in Participation, a Consortium or Association, whenever it demonstrates the legal, financial, and technical capacity, and with experience in similar projects. In this tender process can participate Solicitors of all the countries, according the Guidelines of KfW.

The registered Solicitors can issue their requests for clarifications until December 16th, 2022. The preparation of the Solicitudes, as well as their issue, are of exclusive responsibility of the solicitors. The Solicitudes must be issued at the contracting address, until the 15:00 hours of January 12th, of 2023 (GMT-5, Quito).

The Solicitudes will be opened in public session, in presence of the representants of the Solicitors who wants to participate. The evaluation of the Solicitudes will be performed according the qualification parameters provided in the Prequalification documents.
